

**BYLAW 864-P-02-23
TOWN OF COALDALE
PROVINCE OF ALBERTA**

**BEING A BYLAW OF THE TOWN OF COALDALE
TO AMEND BYLAW NO. 677-P-04-13,
BEING THE MUNICIPAL LAND USE BYLAW**

WHEREAS the municipal council is in receipt of an application to redesignate lands within the municipality.

AND WHEREAS the purpose of proposed Bylaw 864-P-02-23 is to redesignate a portion of lands legally described as:

**LOTS 18, 19 & 20
BLOCK 12
PLAN 6476AA
CONTAINING 0.195 HA (0.481 AC) MORE OR LESS
EXCEPTING THEREOUT ALL MINES AND MINERALS**

From “Commercial C-1” to “Direct Control DC” to provide for the opportunity to develop the land in compliance with the municipal Land Use Bylaw.

AND WHEREAS the said lands are illustrated on the map in “Schedule A” attached hereto.

AND WHEREAS the municipality must prepare an amending bylaw and provide for its consideration at a public hearing.

NOW THEREFORE, under the authority and subject to the provisions of the *Municipal Government Act*, Revised Statutes of Alberta 2000, Chapter M-26, the Council of the Town of Coaldale, in the Province of Alberta, duly assembled does hereby enact the following:

1. A portion of lands legally described and illustrated on the map in Schedule “A” attached hereto shall be redesignated from “Commercial C1” to “Direct Control DC”.
2. Bylaw No. 677-P-04-13, being the municipal Land Use Bylaw, is hereby amended.
3. This bylaw comes into effect upon third and final reading hereof.

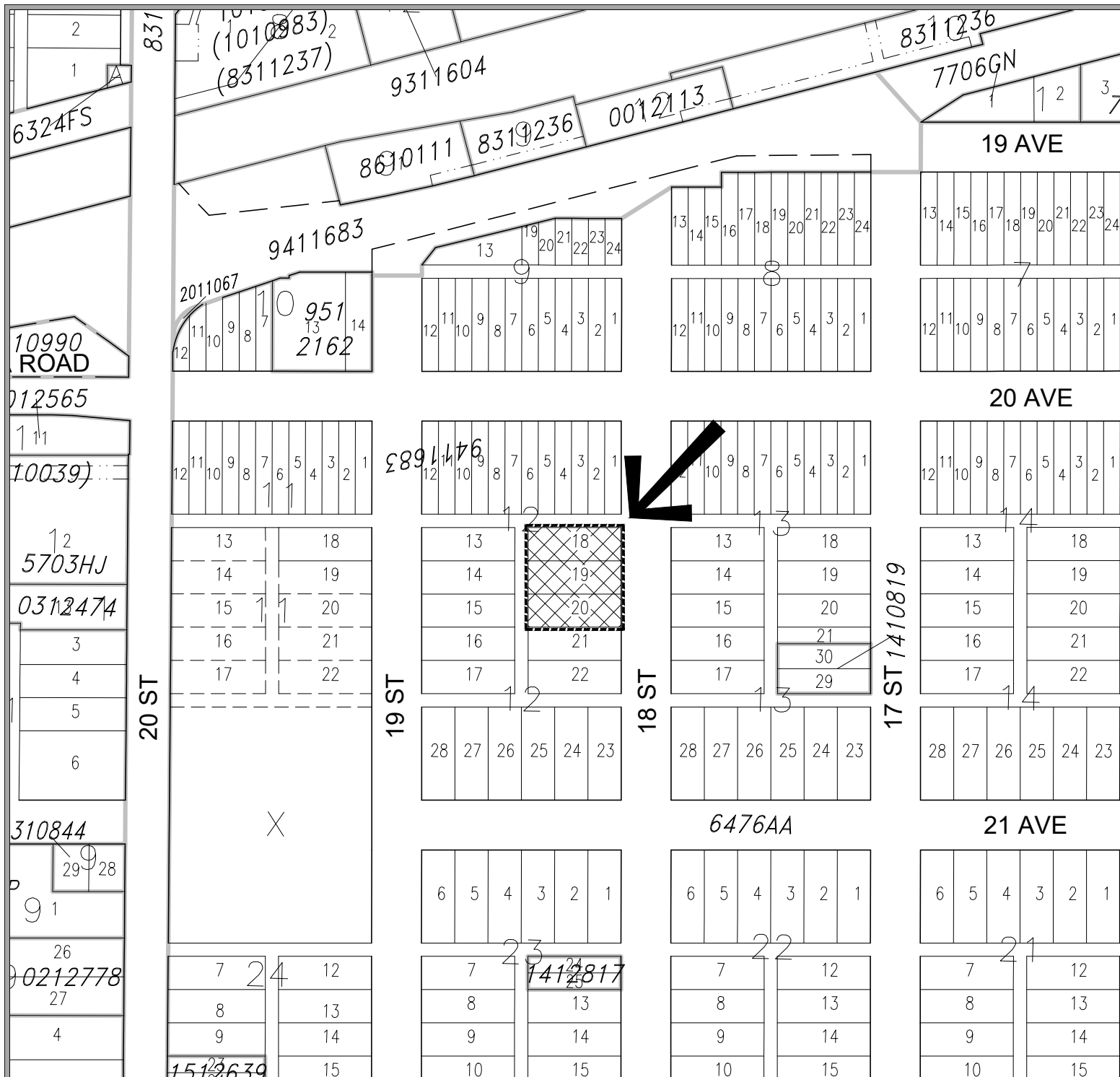
