

**BYLAW 873-P-05-23
TOWN OF COALDALE
PROVINCE OF ALBERTA**

**BEING A BYLAW OF THE TOWN OF COALDALE
TO AMEND BYLAW 677-P-04-13,
BEING THE MUNICIPAL LAND USE BYLAW**

WHEREAS the municipal council wishes to amend the municipal Land Use Bylaw 677-P-04-13.

AND WHEREAS the purpose of proposed Bylaw 873-P-05-23 is to make a series of text amendments to the Land Use Bylaw.

AND WHEREAS the municipality must prepare an amending bylaw and provide for its consideration at a public hearing.

NOW THEREFORE, under the authority and subject to the provisions of the *Municipal Government Act*, Revised Statutes of Alberta 2000, Chapter M-26, the Council of the Town of Coaldale, in the Province of Alberta, duly assembled does hereby enact the following:

1. The Land Use Bylaw 677-P-04-13 is amended by making the additions, deletions and revisions as illustrated in Schedule "A" (attached), including the following matters:
 - a. Revise definitions of "Animation", "Changeable Content", "Luminosity", "Movement/Motion", and "Off-Premises Sign" within Schedule 13: Sign Regulations, Section 2: Definitions.
 - b. Add definitions for "Copy Cycle", "Dwell Time", "Sequential Messages", "Static Copy", "Transition Effects" and "Transition Time" within Schedule 13: Sign Regulations, Section 2: Definitions.
 - c. Delete the definition for "Electronic Sign Content" within Schedule 13: Sign Regulations, Section 2: Definitions.
 - d. Add application submission requirements for "Billboard with Changeable Content" within Schedule 13: Sign Regulations, Section 6: Sign Permit Application Requirements.
 - e. Delete "Projection Styles" within Schedule 13: Sign Regulations, Section 7: Sign Content, Projection Styles and Illumination.
 - f. Revise requirements for "Billboard Signs" within Schedule 13: Sign Regulations, Section 8: Sign Types.
2. Bylaw 677-P-04-13, being the municipal Land Use Bylaw, is hereby amended.
3. This bylaw comes into effect upon third and final reading hereof.
